The latest list of members of the society duly endorsed by the concerned Registrars of the Society with their designation are annexed as per Annexure **Annex – 2**.

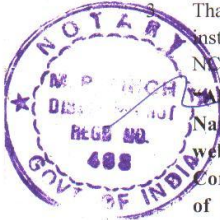
The institution is having a Managing Committee as per provisions of the NCTE Regulations, 2009 and the Managing Committee is consisting of the following:-

- (i) The institution shall be free to post additional relevant information, if it so desires.
- (ii) Any wrong or incomplete information on website shall render the institution liable for withdrawal of recognition.
